**29. Reports: a) District** – Cllr Luggar spoke of the Corporate Plan which is being drawn up with regards to environment and commercialisation in the area. Resolves to get the £1.5M for The Water Sports Centre at Ilfracombe being sought.

b) County - Cllr Edgell spoke of the HATOC meeting which was held today, of which there are 8 around the County. The works to Junction A377/Link Road/Underpass proposal will be going to a full planning committee submitted in about a months time and will be heard probably around October/November. The Oatlands Avenue Group have concerns regarding the removal of trees with regards to exposure from the Link Road. Representations required. There is funding available with significant amounts. c) Sub-Committee Reports. a) Bins & Benches - Contract up and running dog bin collections to commence from 1st July 2019 b) Highways - will communicate with Joe Seymour regarding speed awareness training. Require at least 6 people with DBS checks and a risk assessment carried out for Speed Gun training. School to be contacted to see if any parents willing to participate in this - hedgerows are growing quite fast cutting is in hand - Pothole reporting essential as there are funds available to do this c) Planning - see item 32 below d) Playing Field - Community Ladies say Gazebo quotes have been coming but they are very pricey going to look into this further as a local business may be able to help in South Molton-tidy up team (every 4th Saturday of the month) will be at the Playing Field in July - the roundabout is on hold until either further quotes or funding obtained - e) Finance - going to be working through items of recommendation given by the Internal Auditor f) Flood - meeting to discuss contacts and plan to be arranged g) Rep to Hall - Wi-fi quote will follow shortly h) Rep to J.
